Promoting a Viable Commercial Fishery

- GBA report (Spring 2020) State of Lake Huron and Georgian Bay's Commercial Fisheries - Highlights include:
- 61+ local commercial fisheries and 5 native fishing agreements.
- Catch worth \$4 million+ wholesale value at the dock.
- Predominant catch Lake Whitefish (1.4 million lbs),
- Lake Trout (420,125 lbs), Yellow Perch (313,000 lbs), and Walleye (245,000 lbs).
- 2019 Walleye numbers holding and Yellow Perch up by 3%
- Catch estimated at a \$36 million retail store value.
- GBA's seven suggestions for assisting commercial fishing operators (see GBA's report State of Lake Huron and Georgian Bay's Commercial Fisheries).





Threats to the fishery

Invasive species - GBA's Fisheries reports:

- Future reporting: 2020 Commercial fishing statistics (fall 2021)

2019 Commercial catch down by 16% from previous year:

- 21% decline in high value Lake Whitefish since 2018
- Lake Whitefish decline began in 2010
- Covid upsetting 2020/2021 commercial harvests restaurant closures, limited freezer capacity, transportation to international markets
- Competition foreign operators and aquaculture (lower operating costs)

Aquaculture Committee Changes

- New members added to committee in 2020
- New co-chairs appointed to the committee





Cage Fish Farming Current Status

- 10 open-cage aquaculture operate in Georgian Bay and North Channel, 5 First Nation and 5 subject to licenses/leases
- The 5 licences/leases are set to be renewed in March 2022 and plan to expand their boundaries
- Lake Wolsey site has officially closed (license has been cancelled) but fish still being held there
- One of the FN sites not in operation





Cage Fish Farming Current Status



- Open-cage farms produced 5,360 tonnes (metric tons) of Rainbow Trout in 2019
- This represents 96% of all Rainbow Trout produced and >90% of <u>all</u> commercial aquaculture in Ontario (2019)
- Provincial licencing and LUPs to go from 5 to 20 years
- New licences will have more rigorous EA and only be sited in Type 3 waters



Cage Fish Farming Slated to Grow

- The principal species for aquaculture is still and will remain as Rainbow Trout
- Future candidates for cage culture include Lake Whitefish
- One site now rearing Lake Whitefish for a local market
- Federal government proposes to transition marine salmon farms into land-based operations by 2025





Cage Fish Farming Slated to Grow

- OAA objective is to expand opencage fish farming by up to 30,000-50,000 tonnes annually within next 10 years
- Industry plans to establish and expand moderate-scale cage sites in northern Great Lakes waters, including Lake Superior





GBA Concerns

- Reductions in water quality from nutrient loading and hypoxic events
- Effect of nutrient loading on algae production, particularly blue-green algae (cyanobacteria)
- Impacts of nutrient loading and sedimentation on the benthic invertebrate community
- Effects of invasive species (e.g., dreissenid mussels) attracted to the farms
- Effects on native fish stocks by escapements and disease pathogens
- Possible effects of introducing contaminants and/or chemotherapeutants (e.g., antibiotics) into the environment
- Future climate change effects that could impact water quality and the risk of escapements from storm damage


GBA Major Concern

- Of the listed concerns, nutrient loading into water and sediments is still primary
- Existing cage aquaculture was designated as a Category A activity ("little environmental or social concern") under Ontario's Class EA in 2015
- New applications will have stricter EA screening and be restricted to Type 3 sites
- By comparison, Lake Wolsey with its algae problem considered as Type 1





Committee Activities in 2020-21

- Provided comments to MNRF and MECP stating GBA position (push to Category C) in their review of the Class EA for RSFD
- GBA submission re: Class EA reviewed and approved by EcoJustice
- Met twice with government regulators (MNRF, MECP, DFO, OMAFRA)
- Met with IJC Science Advisory Board re: their Lake Huron 2022 report
- Provided additional input to DFO for development of federal Aquaculture Act (AA)
- Held meeting and established dialogue between GBA and DFO with plans for future meetings re: the AA
- Engaged with others to consider support of studies on aquaculture impacts using AUV ("glider") technology



Committee Plans for 2021-22

- Continue to advocate for designation of cage aquaculture as a Category C activity, once it becomes subject to MNRF's Class EA for RSFD projects
- Further meeting with MNRF, MECP, DFO, OMAFRA in April
- Continue to request release of water quality and fisheries data from MNRF
- Continue to develop relationship with DFO regarding the new AA
- Continue to advocate for greater oversight from DFO re: treaty and other agreements with USA, e.g., Great Lakes Water Quality Agreement
- Continue to reach out to GLEC in advance of the Lake Huron 2022 report
- Engage and capture interest of the public through news and social media
- Provide input into plans for aquaculture research studies in Georgian Bay/North Channel



Future of Aquaculture in Great Lakes

- Ontario is <u>only</u> jurisdiction that allows open-cage aquaculture in Great Lakes
- All are in North Channel and Georgian Bay
- Global trend is transition of open-cage fish farms to land-based systems
- This trend includes marine farms in Canada



- GBA will continue to support the transition of open-cage farms in Georgian Bay/North Channel to enclosed systems or land-based fish farms
- Fish farming impacts on the aquatic environment can be best minimized using recirculating aquaculture systems (RAS), but the capital cost is high

Water Levels

- 2019/2020 all Great Lakes set record highs.
- High water levels impacted, marinas, other businesses, ports and municipal infrastructure, + shoreline and island residents.
- Higher highs & slightly lower lows, with shorter durations between extreme levels, predicted - climate change impacts.
- No certainty predictions rate the probabilities.



Good news: drier weather & low ice cover over the last 6 months; expected normal precipitation levels in 2021; water levels likely to be ~18 inches lower than in 2020 through this year.

Thanks to the major effort of numerous volunteers and GBF/GBA staff, the Symposium and its deliverables were an outstanding success that has provided seminal documentation, and important information that will inform our water levels strategy and knowledge for years to come.



Water Levels 2020/21 – fact vs fiction

- Governments do not control water levels – determined by precipitation, evaporation, ice-cover and run-off etc.
- IJC and control boards not responsible for wider water level range in M-H vs Superior – determined by topographical and hydrological differences.
- Water management plans @ Long Lac/Ogoki basin - no potential flow rate adjustment to manage water levels.
- Control boards managing water levels correctly throughout the system, including Plan 2012.



The truth is that we simply do not have sufficient tools available to make any significant impact on mitigating extreme high or low water levels. More tools are needed.



Water Levels – Comprehensive 12 Point Action Plan

Implications of ever wilder swings from extreme highs to extreme lows. What is achievable? Stop pointing fingers. Focus on what can be done.

Short Term:

- Release of ECCC projected water levels analysis study;
- Improve: modelling techniques & data sources - add scientific expertise;
- Improve/coordinate/expand data collection, frequency, formatting, availability & ease of interpretation; and
- Comment on revised Plan 2012 St Clair River considerations expand Lake Superior Board of Control membership.

Longer Term:

- Revive Great Lakes Water Levels Advisory Board concept; and
- Develop (major) new tools (investments) to address water levels fluctuations cost/benefit analysis.





Water Levels – Next Steps for 2021/22

Affirmative Action vs Impacts and Adaption

Follow up (October) GBF and GBA symposium on impacts and adaption to fluctuating water levels:

- Actual impacts on wetlands, habitat, flora and fauna how adaptable are they?
- What to do (not do) on shorelines erosion
- Docks/boathouses configurations/regulations
- Impacted structures raise or move?
- Vulnerable septic systems options
- Adaption investments for marinas, other shoreline businesses, ports, and municipal infrastructure – what to do?
- Long term planning vs short term reactions
- Wakes what can be done? Waves increasing wind strength
- Navigation issues and technologies rules for channel markers
- Review municipal high water marks? Impact on planning regs.
- Insurance issues information sources government grants





Water Quality – Lake Partner Program

- GBA continues to promote the Lake Partner
 Program all members can help citizen science –
 Ph and Ca
- LPP's data set goes back to 1975, so associations can compare water quality metrics over several decades.
- It is a cost effective program with continuing govt support and many volunteer hours.
- More test sites are needed to improve the GB data set – see website on how to join: <u>https://georgianbay.ca/articles/recreational-waterquality</u>
- LPP lead at GBA Bonnie Blanchard will be reaching out to coordinate/establish association leads & expand testing sites & volunteers





Water Quality – Dock Foam

GBA joined GBF, ToA and MPP Norm Miller – Bill 228 - ban unencapsulated polystyrene foam for dock construction/repairs Why?:

- > The major plastics pollution source in the Great Lakes
- ➢ ~95% of shoreline clean-up materials/Seabin contents
 Impacts:
- Litter foam broken down by animals and sunlight
- Wildlife endangered by foam chewed and consumed
- Bioaccumulation particles accumulate in food chain
- Degradation releases chemicals into ecosystem
 Reasonably priced alternatives are available:

55-gallon plastic drums - resin-encapsulated foam billets - steel floats. **ACTION:**

➢ Continue to support Bill 228 → Law → Regulations (key phase)

Get ON govt, municipalities, FOCA, Boating Ontario, GBA & GBF to work together to - continue gathering scientific information - support transition to alternatives - provide education materials to individuals, manufacturers, contractors and suppliers

Water Quality - GBA Action and Submissions in 2020/21

- Participation in Canada Water Agency strategy and planning process
- Attended and provided input on GBA issues at:
 - GLEC meetings
 - ECCC coastal wetlands project update,
- Advocated to ON govt for:
 - no erosion of Conservation Authorities powers
 - no relaxation of pollution legislation/fines
 - no destruction of wetlands using MZOs

Much of the ongoing work on coastal protection issues, such as sewage system inspections & management and coastal municipality planning matters, such as docks over sensitive fish habitat, involve advocating for the protection of water quality.

2020 – A Summer Like No Other...

With COVID-19 came an unanticipated explosion in boating interest

Issuance of Pleasure Craft Operator Cards:

➤ 73.4% increase

2019 was 145,294 and 2020 was 251,992 Issuance of Pleasure Craft Licenses (June – Dec):

53.5% increase

2019 was 77,969 and for 2020 was 119,680

Calls to the Transport Canada's Ontario Office of Boating Safety doubled

Anecdotally, it was difficult to buy any sort of vessel (motorized or human powered) or get repair parts. Transport Canada and Boating Ontario expect this to continue.



2020 – A Summer Like No Other...

According to OPP statistics:

- Fatalities were up 78% (2 in Georgian Bay)
- 91% of fatalities were NOT wearing PFDs
- About 50% were on human powered vessels
- Over 50% were in the cold-water seasons (Jan-June and Sept-Dec)
- 94% of fatalities male and 25% in the 45 to 55 age group
- 66% of fatalities occurred when conditions were clear

Complaints were up - PWCs and aggressive vessel operation were most common charges (and warnings) were up substantially; except for impaired





/// what3words

- OPP announced on December 1, 2020 that they would be using the app what3words in emergency response
- This is a game changer that will improve emergency response
- It has already been used successfully in rescue situations
- It is free and easy to use

Georgian Bay for Everyone

Modernization of PCOC and Pleasure Craft Licensing

Transport Canada is proposing the modernization of the Pleasure Craft Operator Card (PCOC) and Pleasure Craft Licensing Program.

Comments will likely be requested this fall, with a look to implement the changes in the fall of 2022.

Proposed Changes that affect us:

Pleasure Craft License:

- New licenses will have a 5-year term from the current 10year term and licenses issued prior to 2010 that were considered "lifetime" will have a 5-year term as well
- \$15 fee
- Sail-only vehicles larger than 6m will require a license (Human powered vessels are not included)

Pleasure Craft Operating Card:

- No direct changes for us as users
- Changes to fees for course providers
- Boat rental establishments will require a PCOC card rather than the existing (limited) rental checklist to prove competency



Safe Quiet Lakes on Operation Decibel

- The plan is to have legislated permissible noise levels from boats as they have in Europe and the US
- In 2020 the GBA with board approval joined the Decibel Coalition and in July wrote to our Associations in support of the program
- GBA is also helping connect with municipalities
- Thanks to Andy Metelka who is assisting with decibel devices and the science of sound





Fire Danger Awareness

Ontario's Wildland Fire Season began on April 1st and runs through to the end of October

- Last summer we began posting a weekly update, just prior to the weekend, detailing the fire ratings for our Georgian Bay municipalities and outlining what is allowed under those ratings. We will continue this again this year.
- Par033 Freedom of information request for the MNRF report on the fire continues in the adjudication stage.

Membership Numbers

- Ebb and flow of Association membership numbers is a regular and normal occurrence.
- Often decreases are offset by increases in subsequent years.
- In 2020, much of the membership attrition traced to Associations with high proportion of US members who opted not to renew following pandemic border restrictions. Longer term implications hopefully should rekindle US membership.





Membership Numbers

- Association and GBA membership growth "spikes" follow major galvanizing Georgian Bay residents' issues (i.e., water level extremes, over-development, etc.)
- Despite normal fluctuations, stemming membership attrition in some Associations and reinforcing the importance of GBA membership generally, are the 2021 GBA Membership Committee priorities.

Land Use in Georgian Bay

- GBA will inform membership on the formation of any Indigenous Protected and Conserved Area (IPCA) and Crown Land status issues.
- GBA to provide associations and membership with reliable information to better understand any changes in land use in Georgian Bay.



Indigenous Protected and Conserved Areas (IPCA)

Potential model for protecting crown land and adding to parkland

Alignments with GBA on:

- Preservation of biodiversity
- Conservation economies (Food harvesting and Ecotourism)
- Sustainability models/principles
- Responsibility to maintain the land

Ways to create an IPCA:

- Top down designation (government)
- Within an indigenous community at a grassroots level when the community makes it happen
- As a mind set create your own Protected and Conserved Area





Biodiversity Goals and Targets for Canada

Target 1: By 2020, at least 17% of terrestrial areas and inland water, and 10% of marine and coastal areas of Canada

Next Targets: Protect 25% of land and oceans by 2025 and 30% by 2030.
